



Climate Ambassador Agreement

As a Blessed Tomorrow Ambassador I will help people to understand the links between climate and health, the spectrum and benefits of climate solutions, and opportunities to act and advocate. I am empowered to inspire my family, congregation,, the public, and policymakers on climate solutions that help protect the health and wellbeing of our families and communities now, and ensure a prosperous, just, and secure future.

To help facilitate Ambassador presentation opportunities, Blessed Tomorrow will:

- Provide a one-hour version of the Blessed Tomorrow Ambassadors Training, inclusive of talking points and citations, for me to use in presentations, along with other supplemental resources and handouts. Materials will be updated annually (at minimum).
- Provide periodic research updates pertinent to the presentation material via a newsletter, and access to a website materials and recorded webinars.
- Collaborate on customizing the content of the training as necessary.
- Offer customizable promotional materials to use in soliciting participation in the training.

As a Blessed Tomorrow Ambassador, I agree to:

- Give at least 3 Blessed Tomorrow presentations per year for groups of 15 people or more using the presentation materials, talking points, and other resources provided to me by Blessed Tomorrow with minimal edits or personalization, per the Creative Commons 4.0 license of the materials. I will have primary responsibility in securing these speaking engagements, and will also consider requests that come to me from Blessed Tomorrow and/or my faith organization.
- Allow Blessed Tomorrow and my faith organization (through which I received this training) to publicly list my name, title, affiliation(s), city, state, and speaking availability as a Blessed Tomorrow Ambassador on their websites. I will also add the Blessed Tomorrow Ambassador designation to my public profiles. I will provide contact information to program administrators to help connect me with presentation requests.
- Take at least 2 actions to advocate for climate solutions per year from the following list:
 - Sign on to a letter supporting climate solutions from my faith organization or other organizing body

- Submit an Opposite the Editorial page (Op Ed) or Letter to the Editor (LTE) to a newspaper or periodical of record
 - Call or visit my local, state, or national representative(s) to let them know I support equitable climate solutions that protect human health and wellbeing
 - Publish a blog post or thought piece encouraging people of faith to act on climate solutions on the website of my congregation or other affiliated organizations
 - Attend a candidate forum to raise climate action as a local, state, and national priority
 - Participate in an advocacy action that arises in my state, city, and profession
- Provide timely input and feedback through the mechanisms provided to Blessed Tomorrow about the presentations I give and advocacy actions I take.
 - Pursuant to the Blessed Tomorrow Path to Positive Vision and Principles, support only those policies that meet the requirements therein. Specific political candidate or party endorsement is not permitted under the Blessed Tomorrow Ambassador designation.
 - Ensure all actions taken as an Ambassador are conducted voluntarily. Not accept any financial compensation from any organization, partner, individual, or another host of events where I give Blessed Tomorrow presentations, or monetize my Blessed Tomorrow speaking engagements in any other way.
